**ORDER DENYING BRIDGESTONE AMERICAS TIRE OPERATIONS, LLC'S
MOTION TO DISMISS FOR LACK OF PERSONAL JURISDICTION**

This matter came before the Court on Bridgestone Americas Tire Operations, LLC's
("BATO") Motion to Dismiss for Lack of Personal Jurisdiction ("Motion"). The Court reviewed
the briefing, conducted argument on October 11, 2019, and is otherwise fully advised in the
premises.

The Court finds that BATO consented to general jurisdiction by registering to do
business in New Mexico and further finds that there is specific jurisdiction over BATO in this
case.

Consequently, the Court finds that BATO's Motion is not well taken and should be denied.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED that BATO's Motion to Dismiss for Lack of Personal Jurisdiction is denied.
